

RESULTS OF SAVE OUR STREETS/RESEARCH CO. PROVINCE-WIDE SURVEY (SEPT. 9-12)

- The online survey of a representative sample 1,200 British Columbians was conducted from September 9 to 12 by Research Co.
- The survey has a margin of error of +/- 2.8 percentage points, nineteen times out of twenty.
- The Interior includes the Thompson-Okanagan and Kootenay regions.
- Northern B.C. includes the Nechako, Northeast and North Coast regions
- The Lower Mainland includes communities from Whistler to Hope, as well as the Sunshine Coast.
