

# SAVE OUR STREETS CONFIRMS JUSTICE, HOUSING, ADDICTIONS, MENTAL ILLNESSES AND POLICING LEADERS FOR COMMUNITIES DRIVING CHANGE FORUM (JAN. 23)

VANCOUVER, B.C (Dec. 20, 2024) – Some of British Columbia's foremost leaders in the areas of policing, the justice system, addictions and mental illnesses, and housing will gather in Vancouver on January 23<sup>rd</sup> to explore evidence-based solutions to the crisis level of crime, violence and public disorder being experienced in communities throughout B.C.

The day-long **Communities Driving Change Forum** at the Morris J. Wosk Centre for Dialogue in Vancouver will feature four professionally moderated, non-partisan and future-focused panel discussions on the justice system, housing, policing and addictions and mental illnesses (See agenda below). Recognizing the need for possible new approaches, greater collaboration and informed decision making when it comes to addressing these decades-old issues, SOS has assembled an extraordinary group of subject matter experts, each with extensive experience and expertise in their fields.

"I want to thank all of our panelists for joining us and for their commitment to bringing about meaningful change in how we address these issues," said Jess Ketchum, Co-founder, SOS. "The time is now for British Columbians to re-evaluate where we are on these critical issues and develop collaborative, evidence-based approaches that can serve as a new model for addressing these issues in B.C. and beyond. We're confident the Communities Driving Change Forum will be an important step in that process."

The Communities Driving Change Forum is the latest high-profile initiative by the 120-member coalition, which includes community and business organizations from across B.C. In the fall, SOS helped ensure crime and public safety was a key election issue through a province-wide survey and press conference which demonstrated widespread public dissatisfaction with how governments are addressing public safety, justice, repeat offenders, retail crime, and addictions and mental illnesses treatment.

Following the provincial election, SOS delivered to Premier David Eby a letter with 25 priority actions items aimed at making communities safer, restoring confidence in the justice system, better addressing addictions and mental health issues, and improving the quality of life of all British Columbians.
