

## LIVESTREAMED SOS FORUM TO EXPLORE HOUSING SOLUTIONS TO ADDRESS PUBLIC SAFETY, MENTAL HEALTH AND ADDICTION RECOVERY

BC Housing, Covenant House and Former Vancouver Mayor highlight expert housing panel

VANCOUVER, B.C (Jan. 20, 2025) – Across British Columbia, the impacts of homelessness and housing unaffordability make it clear BC is experiencing a housing crisis that is eroding public safety in every community and negatively affecting our ability to support people experiencing mental health and addiction issues.

At the Save Our Streets **Communities Driving Change Forum** on January 23, the housing panel, called **A Place to Call Home: The Role of Housing in Combatting Crime, Violence and Public Disorder**, will explore successful housing models, and what the challenges are to defining and delivering housing along with services that make life better for individuals, and safer for the community.

Moderated by **Richard Zussman** of Global, the panel will feature:

- Heidi Hartman, Associate Vice President of B.C. Housing, the organization which develops, manages and administers a wide range of subsidized housing options across the province.
   B.C. Housing works with the ministry responsible for housing and about 800 housing providers to address critical gaps across the housing continuum.
- **Deb Lester**, CEO, Covenant House Vancouver. Covenant House Vancouver's purpose is to provide, shelter, support and services to help youth aged 16-24 who are experiencing or are at risk of experiencing homelessness, trafficking or exploitation.
- Sam Sullivan, Founder, Global Civic Policy Society. Sullivan is a former BC Cabinet Minister and Mayor of Vancouver, who has a long history of involvement in improving Vancouver. During his time as Mayor, more than 2,000 units of social housing were initiated, and Vancouver experienced its largest drop in property crime in 50 years.

Held at the Morris J. Wosk Centre for Dialogue in Vancouver, the Forum will speakers and professionally moderated, future-focused panel discussions (See full agenda <u>online</u>).
